**1. Brief facts of the complaint**

The complainant has filed a complaint against traffic police officials for demanding bribe and challaning him for over speeding. He has alleged that on 3.12.2017, he alongwith his family was going to attend a marriage ceremony at Sonipat. On the way he was intercepted at Outer Ring Road by some traffic police officials, one of whose name was Devender Singh and challaned for Rs. 400/- for over speeding. They also demanded Rs. 1000/- as bribe otherwise threatened to impound the vehicle. He has also alleged of abusing and manhandling by the alleged traffic police officials. He has requested for legal action in the matter.

**2. Proceedings in the Public Grievances Commission**

The PGC convened its first hearing in the complaint on 26<sup>th</sup> February, 2018, when the following were present:-
