1. Brief facts of the complaint

Shri Joginder Dedha filed a grievance in PGC on 15.3.2017 regarding fixing of illegal hoardings at Mayur vihar East Plaza, Mayur Vihar Noida Link Road, sites stand opposite Star City Mall, Hotel Holiday Inn Flyover, etc.

2. Proceedings in the Public Grievances Commission

The PGC has convened six hearings since 01.08.2017 and in the last hearing held on 5th March, 2018 the following were present:

3. Relevant facts emerging during the hearing

3.1 At the last hearing held on 29th Jan.2018, the directions of PGC were as follows :

The partly action has been taken by the EDMC officers. Commercial Officer, EDMC is directed to confirm about the jurisdiction of area of the remaining Unipoles and if they are in Delhi the same may be demolished immediately and an Action Taken Report be submitted during the next date of hearing through a senior officer well conversant about the facts of the case.


3.2 During the hearing on 05.03.2018 Sh. Vineet Gautam, Commercial Officer, EDMC was himself present and submitted an ATR giving the status of each Unipole along with photographs.

3.3 The complainant was not present during the hearing.

4. **Directions of the PGC**

Sh. Vineet Gautam, Commercial Officer, EDMC is directed to submit a detailed reply with respect to each photograph and in support of the department's order with respect to each unipole.

Further it is informed by the Commercial Officer that a similar complaint from Sh. Rajender Dedha is also pending wherein the allegations are the same. On receipt of the detailed reply the same is to be examined and if it refers to the same area / complaint both the matters should stand closed at the level of PGC.
