1. Brief facts of the complaint

3. Relevant facts emerging during the hearing

3.1 At the last hearing held on 29th Jan. 2018, the directions of PGC were as follows:

And the date. Commissioner to ensure that the senior officer well conversant with the case is present during the hearing in PGC.

3.2During the hearing held on 05.03.2018 neither any officer is present nor any status report has been filed.

4. <u>Directions of the PGC</u>

- It was reported to the Commission that the buildings are unauthorizedly built and the matter has been brought to the notice of the Commission in the month of July, 17 when the construction was in progress. Now after 6 months it is learnt that the building has been completed and has been sold out thereby making the proceedings in the Commission in fructuous. At no point of time the officials of MCD attended the hearing which shows their disregards to the Commission and confirms presence of a nexus between the MCD officials and builders who have carried out illegal construction with impunity.
- 4.2 **Chief Vigilance Officer, EDMC** is requested to personally look into the matter and get it enquired, investigated to fix the responsibility of the MCD officials for initiating disciplinary proceedings against each of them for dereliction of discharge of duties and misuse of their official position and submit a report to this Commission.
- 4.3 With the above directions the case is closed at the level of PGC.
