1. Brief facts of the complaint

Sh. P.C. Jain filed a complaint in PGC on 21/9/2016 regarding denial of PGT Selection Pay by DDE (South East), GNCTD.

3. Relevant facts emerging during the hearing

An ATR has been filed on behalf of Dy. Director of Education (Aided & Public Schools), South East District, GNCT of Delhi stating that "*the Competent Authority has approved the grant of Selection Scale to Shri P.C. Jain, Teacher (Retd.) vide order dated 11.01.2018.*"

As per the ATR given by the Dy. Director of Education (Aided & Public Schools), South East District, GNCT of Delhi, orders have already been issued for grant of Selection Scale to

Shri P.C. Jain on 11.1.2018. The complainant has given a copy of it personally to the School Authorities for fixation of his pay and revision of pension etc.

It is almost two months and the process is not completed.

4. Directions by PGC

Ms.Usha Chaturvedi, Dy.Director of Education (South East), Govt.of NCT of Delhi, is advised to follow up the matter with the School Authorities for early revision of pay and pension and release of arrears in respect of the complainant.

In view of the above advice of the Commission, the case of the complainant is closed in PGC.
