1. Brief facts of the complaint

3. Relevant facts emerging during the hearing

During the hearing held on 05.02.2018 the directions of the PGC were as under:

3.1 Commissioner EDMC may take corrective measures as no one is attending the hearing from his department for the last two hearings in this case. Also in other cases EDMC officers remain absent in hearings. The Commission has taken adverse view of it.

Deputy Commissioner (Shahadara North Zone) is directed to initiate the desired action to remove the unauthorized / illegal parking in the area under reference and submit an action taken report during the next date of hearing.

- 3.2 During the hearing on 12.03.2018 Sh. Kishan Swaroop, AO is present and submitted a report stating that in reference of above subject and PGC grievance reg. encroachment on road between GT Road to Old Seelampur Shiv Mandir by 3 Wheelar Tempo Vehicles. The stretch in question falls under the jurisdiction of Shahadara South Zone, EDMC.
- 3.3. No officer is present in the hearing from Shahadara South Zone.
- 3.4 The complainant has not attended even a single hearing.
