1. Brief facts of the complaint

The complainant has filed a complaint against IO of FIR No. 416/17, PS Sangam Vihar for not arresting the accused deliberately and weakning her case. She has stated that the IO has connived with the accused persons and has not invoked appropriate sections thus weakening her case and saving the culprits from arrest. She has alleged that her husband was attacked with rods on his head but the IO did not invoke the proper sections. She has requested for impartial enquiry by some lady police officer.

An ATR has been filed by SI Sudhir Joon, PS Sangam Vihar, stating that “ during the course of investigation, both accused Pukhraj and Prem Singh were given notice and were bound in the above case. The chargesheet was prepared on 5.11.2017 and was sent to the court of Ms. Saloni Singh (MM Mahila Court) Saket for trial vide R/C No. 635/21/17 on 6/11/2017. The NDOH of the case is 9/4/2018.”
