**1. Brief facts of the complaint**

The complainant has filed a complaint stating that she is the owner of 3<sup>rd</sup> Floor of H.NO. 5872, 3<sup>rd</sup> Floor, Gali NO. 15, Sikligram, Nabi Karim, Delhi and the way towards 3<sup>rd</sup> Floor is from south side. She has alleged that Shiv Nath Parsad and his brother Ram Kishore residing in House NO. 7043, Marwari Basti, Nabi Karim harass her physically and mentally and pressurize to sell her flat at lowest rate. They also restricted the way towards 3<sup>rd</sup> Floor. On 19.7.2017, they illegally prevented her upstairs way and threatened to kill her. She was also beaten by them very badly. She made a call at NO. 100 but police did not register the case. She also alleged that SHO/Nabi Karim and SI Rishi Pal took bribe of Rs. 2 lakh from the alleged person to favour them. She has requested to provide security for her life and property.

The PGC convened its first hearing in the complaint on 27<sup>th</sup> September, 2017 , the second hearing held on 7<sup>th</sup> February, 2018 and the third hearing held on 14<sup>th</sup> March, 2018, when the following were present:-
