1. Brief facts of the complaint

The complainant has filed a complaint alleging illegal activities and sale of illicit liquor in the area of Village Razapur in connivance with the local authorities and beat staff. Complainant has also alleged that some local residents of Village Razapur were suspected to be involved in selling illegal liquor in the area. She has also mentioned the name of persons involved in selling illegal liquor i.e. Santosh w/o Uday, Jagmal s/o Rishal, Dharmo wife of Dharpal etc. etc.. The complainant has requested for legal action in the matter.

2. Proceedings in the Public Grievances Commission

The PGC convened its first hearing in the complaint on 15th February, 2018 and the second hearing held on 15th March, 2018, when the following were present:-

3 Relevant facts emerging during the hearing

An ATR has been filed by SI Vijay Singh, PS Prashant Vihar, stating that " in the above noted case FIR NO. 488/17 u/s 33/38, Delhi Excise Act was registered against the alleged Mrs. Santosh upon the statement of Beat Ct. Vivek NO. 2138/RD. In total of 06 cases of Excise were registered in the year 2017. The above mentioned case FIR No. 488/17 has already been chargesheeted and rest of the cases are under investigation. It is, therefore, requested to

kindly file the complaint as petrolling in the area as well as a strict watch has been kept to curb the illicit selling of the liquor whereas the case FIR NO. 345/17 has already been chargesheeted on 2.2.2018.

4. Directions of PGC

Police is once again advised to keep close watch on the activities of the suspects, take legal action for any violation and also to keep the complainant informed about the action taken.

Commissioner (Excise) is advised to take action on the complaint as per the provisions of Excise Act. A copy of the complaint is being sent herewith for necessary action.
