**1. Brief facts of the complaint**

The complainant has filed a complaint of abduction of his daughter , aged 15-16 years on 25.12.2017. He has alleged that Kishore s/o Shri Suresh, a neighbour alongwith his associate Monu forcefully abducted his daughter in a vehicle. He has also alleged that he was extended threats by the alleged persons. He has requested for legal action in the matter.

**2. Proceedings in the Public Grievances Commission**

The PGC convened its first hearing in the complaint on 9<sup>th</sup> March, 2018, when the following were present:-

An ATR has been filed by SI Prem Raj, PS Vijay Vihar, stating that “ on 29.12.2017, a case vide FIR NO. 1480/17 u/s 363 IPC was registered at P.S. Vijay Vihar on the complaint of Shri Khandu Singh and investigation of said case was entrusted to ASI Net Ram. During the course of investigation kidnapped girl Baby Kaur was recovered and she was medically examined at BSA Hospital. Statement u/s 164 Cr.P.C. got recorded before the Hon’ble Court Rohini, Delhi. During the course of statement u/s 164 Cr.P.C. victim Baby Kaur had not
