# 1. Brief facts of the complaint

The complainant has stated that some un-social elements sit nearby Dinesh Tea Stall and harass as well as eve- tease the girls and women. The facts are in the knowledge of local police. He lodged a written complaint on 14.11.2016 in PS Seelampur, ACP/Seelampur and DCP Office. Thereafter, he again made complaint on 29.11.2016 but no action was taken. Third time he made written complaint on 16.3.2017 in police station and on 7.4.2017 in ACP office and DCP Office but neither any statement was recorded nor any action was taken. He further alleged that the Division officer and beat constable are favouring the other party and furnish false report to their senior officers. The complainant has requested for necessary action in the matter.

#### 2. Proceedings in the Public Grievances Commission

The PGC convened its first hearing in the complaint on 31<sup>st</sup> July, 2017, the second hearing held on 25<sup>th</sup> September, 2017, the third hearing held on 29<sup>th</sup> January, 2018 and the fourth hearing held on 12<sup>th</sup> March, 2018, when the following were present:-
