### 1. Brief facts of the complaint

The complainant has filed a complaint stating that HC Kishan Kumar alongwith one person claiming to be police official forcibly entered into her house at about 7.00 p.m. on 21.5.2017 by pushing her paralysed husband and started raising threats that "LANGDE , TU AUR TERI BIWI KO ABHI JAIL ME BAND KERENGE, CHAL THANE CHAL". The HC held her husband by collar and was threatening him. On her intervention, he also pushed her from her breast and said "OYE SALLI TU WAHIN KHADI REH" and further said "TUM DONO KE KHILAAF COMPLAINT HAI, ISLIYE TUMHE BAND KARUNGA". She also alleged that HC illegally detained her and her paralyzed husband at PS Paschim Vihar from 6.45 p.m. to 9.15 p.m. on 22.5.2017. They were so scare with the threats and the indecent and inappropriate behavior of the HC Krishan Kumar that she and her husband could not sleep properly and concentrate on anything. The complainant has requested for stern legal action against the culprit HC Kishan Kuamr and other unknown person.

### 2. Proceedings in the Public Grievances Commission

The PGC convened its first hearing in the complaint on 27<sup>th</sup> September, 2017, the second hearing held on 7<sup>th</sup> February, 2018 and the third hearing held on 14<sup>th</sup> March, 2018, when the following were present:-
