**1. Brief facts of the complaint**

Shri Naushad filed a grievance in the Commission on 05.09.2017, regarding unauthorized construction in 5 properties bearing No. 1127/E, 1157/E, 30/29, 1156/E and 1227/C, Hariom Gali No. 2, Babarpur, under the jurisdiction of Shahadara North Zone, EDMC.
