Shri Hari Singh filed a complaint in PGC on 28/12/2016 for non-releasing of benefits as per MACP/ACP (Order No.56 dated 3.2.2015)

3. Relevant facts emerging during the hearing

An ATR has been filed on behalf of Section Officer (ACP Cell), Services Department, GNCTD stating that *"the case of Shri Hari Singh, Retired Ad-hoc DANICS is under submission for seeking administrative approval of Pr.Secretary (Services), GNCTD for placing the case along with other cases before the designated Screening Committee. The matter is under active consideration."*
