**1. Brief facts of the complaint**

Sh. Sandeep Kumar filed a grievance stating that he had worked with National Health Mission (NHM) from Feb. 2013 to 5<sup>th</sup> August 2016 but they have not paid his salary and arrear of the above period. He has requested PGC to do the needful.

**2. Proceedings in the Public Grievances Commission**

The PGC convened its hearings in the case on 20.12.2017, 16.1.2018 and latest on 14.3.2018 when the following were present :-

An ATR has been filed by – CDMO cum Mission Director (IDHS-NED) stating therein that:-

“The pending dues/arrears of Mr. Sandeep Kumar (Ex-pharmacist –IDHS North East District) to the tune of Rs. 58,380/- has been released through PFMS, notwithstanding Mr. Sandeep Kumar could not handed over the charge of DIDHS (NED) store to next incumbent.

Further Mr. Sandeep Kumar did not complete one month notice period, therefore as per the terms and conditions of IDHS (NED) one month remuneration of Mr. Sandeep Kumar has been forfeited.”
