Shri Shiv Shankar Kumar, Section Officer (ACP Cell), Services Department, GNCT of Delhi is directed to coordinate with the concerned agencies in this regard and attend the next date of hearing in PGC along with an action taken report.

3.2 During the hearing on 15.03.2018 Sh. Suraj Kumar, Senior Assistant is present and submitted an Action Taken Report stating that with reference to the Hon'ble PGC order dated 22.02.2018, I am directed to inform that the case of Sh. Ashok Kumar Khera, Retd. Gr.II (DASS) was placed before t he Screening Committee in its meeting dated 13.03.2018 for consideration of his case for 3rd financial upgradation under MACP scheme from the existing grade pay of Rs. 4600/- (PB-II) to the immediate next higher grade pay of Rs. 4800/- in the hierarchy of pay bands.
