1. **Brief facts of the complaint**

Sh. Kela Singh filed a complaint in PGC on 1/4/2015 regarding construction of boundary wall of Drain No.46, Khasra No.262/2 at Village Mungeshpur, Delhi-110039.

2. Proceedings in the Public Grievances Commission

The PGC convened hearings on 29th April, 2015, 04th June, 2015, 07.10.2015, 30.11.2015, 15.3.2016, 03.5.2016, 31.5.2016, 22.6.2016, 20.7.2016 when the case was closed. The hearings in the complaint (after re-opening) were held on 31.5.2017, 14.6.2017, 19.7.2017, 14.9.2017, 14.10.2017, 04.10.2017, 21.11.2017, 20.12.2017, 30.1.2018 and the latest hearing on 20.03.2018 wherein the following were present:-

3. Relevant facts emerging during the hearing

In pursuance of the previous hearing, the complainant has not taken the villagers who are in his opinion affected by the construction of boundary wall to the BDO Office

to reconcile the records as advised by the Commission vide its order dated 30.01.2018. However, in today's hearing, four such villagers are present and one of them has stated that there are altogether seven villagers who are affected by the construction of the boundary wall and they have the documents to prove their rights regarding ownership of the plot. The BDO who is present has stated that he is open to any re-examination of the matter / documents. The four villagers present during the hearing in the Commission are advised to ensure that they along with other three persons who are allegedly affected, to meet the BDO, North, in his office at 10.30 A.M. on 23.3.2018 positively along with the documents. After examining their documents and hearing their grievances, BDO may prepare a consolidated report and discuss the matter with District Magistrate (North), GNCTD so that she would be able to finalise the issue. Whatever decision is taken by the D.M.(North) would be final. As per the final decision of the D.M.(North), the demarcation will also be finalized and the Irrigation & Floor Control Department will execute the work which is already ready for execution.

4. <u>Directions by PGC</u>

In view of the above advice of the Commission to District Magistrate (North) and BDO (North), Alipur, GNCTD, the case of the complainant is closed in PGC.
