1. Brief facts of the complaint

The complainant has filed a complaint against the family of her landlord stating that she is a unmarried teacher and residing in alleged's house since October, 2011 on rent. In 2012, November-December, landlord's son Jagmohan Sharma stated to be government officer in Udyog Bhawan came to her room and said that he liked her and told that he would come to her room and knock it around 12-1.00 in the night and would like to have physical relations with her for which he would exempt the rent and also bear the expenses of clothing, food etc. On which she asked him to go out of her room saying that he was a married person having children so such sort of things are not desirous of him. While going out of the room, he threatened her with the dire consequences if she did not agree to his offer. She has also alleged of attack of her life and implicating her in false cases. She has requested for clubbing all the 11 FIRs registered regarding her case and be got investigated to finalise the case. She has requested for legal action in the matter to get her justice and also requested for providing security to her.

2. Proceedings in the Public Grievances Commission

The PGC convened its first hearing in the complaint on 26th December, 2016, the second hearing held on 27th February, 2017, the third hearing held on 24th April, 2017, the fourth hearing held on 10th July, 2017, the fifth hearing held on 11th September, 2017, the sixth hearing held on 19th February, 2018 and the seventh hearing held on 19th March, 2018, when the following were present:-

Considering the past track record of the complainant, and the submissions put forth by the ACP present during the hearing with reference to the enquiries conducted by him, the matter stands closed in the Commission.
