#### **1. Brief facts of the complaint**

Shri Chander Mohan Tiwari filed a grievance in the Commission on 25.01.2018 against selling of bricks / iron rods / debris of erstwhile MCD Quarters from Qr. No. 1 to 36, near Radha Krishan Mandir, adjacent to B, Pocket, Durga Park, Dilshad Garden, Delhi – 110095 by Sh. Parvesh alias Dara, as EDMC employee working in ward No. 29 – E (holding Mobile No. 9540981212).

#### **2. Proceedings in the Public Grievances Commission**

The PGC has convened first hearing in the matter on 26.03.2018 and the following were present

#### **3. Relevant facts emerging during the hearing**

3.1 Sh. A.K. Jain, AE (N-II), Shah. North is present in the hearing and submitted a report stating that it is submitted that Sh. Ram Niwas Goel, Speaker, Delhi Legislative Assembly held a meeting in his chamber on 03.11.2017 at 3.00 p.m. at Delhi Legislative Assembly, Old Secretariat, Delhi regarding different issues pertaining to AC-62.. In which, one issue was i.e. “status of vacant MCD quarters (declared dangerous) in Dilshad Garden, Delhi”. During the meeting, it has been desired by the Hon'ble Speaker that these quarters should be demolished

and remove the rubbish/malba to avoid any misuse / miss-happening. These quarters are in a land of 4000 sqm. Area at Dilshad Garden, which are lying vacant since long time.. Accordingly, after obtaining the permission from competent authority, this division is demolishing the existing abundant quarters with the help of JCB. Building rubbish and malba is going at C & D base plant, Shastri Park. Departmental labour is deploying at site for watch and ward during the demolishing work and removal of rubbish / malba.

#### **4. Directions of the PGC**

Sh. A.K.Jain, AE submitted a report stating that the said quarters are being demolished in pursuance of orders of Hon'ble Speaker, Delhi Legislative Assembly. The entire rubbish, malba of demolished quarters is being transported by departmental trucks, using the departmental machinery. Almost 90% of the debris has been removed. The allegations against the EDMC officials of selling the govt. property and making money etc. are baseless and mischievous. The officials of EDMC are being deployed at the site to protect the property of the department.

No further action in the matter is warranted. The matter stands closed at the level of PGC.
