#### 1. Brief facts of the complaint

Sh. B.N.Khurana has filed a grievance in PGC on 15.10.2013 regarding removal of illegal reliance tower installed on the roof of top floor of property No. FD-38, Tagore Garden, New Delhi – 110027.

#### 3. Relevant facts emerging during the hearing

#### 3.1 At the hearing held on 11.10.2017 the directions of the PGC were as under:

Shri S.P. Garg, AE (Building), West Zone, SDMV is advised to ensure t hat the tower under reference should be completely defunct before the next hearing. No further date will be given and if the work is not done the matter will be referred to the Vigilance Department.

- 3.2 During the hearing on 21<sup>st</sup> March, 2018 Sh. Srikant Prasad is present.
- 3.3 The complainant is also present and also submitted that though the illegal tower is not functioning at present but is yet to be completely defunct/dismantled by the SDMC West Zone.

# 4. <u>Directions of the PGC</u>

Since the tower was installed with the approval and permission of the local Corporation authorities it is obligatory on the part of the West Zone, SDMC to ensure that the structure is removed at the earliest. Deputy Commissioner, West Zone, SDMC to ensure that the same is done in a time bound manner and an action taken report is submitted to this Commission.

With the above directions the matter stands closed at the level of PGC.
