## 1. Brief facts of the complaint

Shri Abdul Rehman filed a grievance in the Commission on 06.12.2017 regarding construction of a basement below the Delhi Jal Board Pipeline towards Wazirabad Road and running unauthorized rehri patri market on the roof of the basement by Shri Ramdhan and requested the Commission to take cognizance of the matter and order accordingly.

## 2. <u>Proceedings in the Public Grievances Commission</u>

The PGC has convened three hearings in the matter and at the last hearing held on 12<sup>th</sup> March, 2018 the following were present:

## 3. Relevant facts emerging during the hearing

#### 3.1 At the last hearing held on 12.03.2018 the directions of the PGC were as under:

The Commission has taken a serious view of the absence of the PWD officer and non submission of report. **Executive Engineer(C), (East) Roads, PWD** is directed to inspect the said property and submit a status report, in person, in a week's time.

3.2 During the hearing on 26.03.2018 Sh. Pratap Singh, EE is present and submitted a report stating that regarding construction of a basement below Delhi Jal Board pipeline towards Wazirabad Road and running unauthorized rehri patri market on the roof of the basement by Sh. Ramdhan the submission is below:

No roads / footpath / drain etc. have been constructed by PWD in that stretch as 3 Nos of big pipeline of DJB are passing through that portion.

As far as unauthorized structure is concerned, EDMC is authority to remove this type of illegal construction.

It has been seen that the kachchra / malba has been filled over & below the DJB pipeline in front of Shiva Tower for parking etc.

At present it has been seen that under the DJB pipeline structure not appeared. The matter pertain to DJB or EDMC.

3.3 As per the status report filed by PWD authorities the area in question does not fall in the jurisdiction of the PWD and the same belongs to Delhi Jal Board.

# 4. <u>Directions of the PGC</u>

It appears from the photographs that the area where sewage pipe line have been laid down by the DJB, has been filled with debris to create access between the main road and shops etc. as a result the Delhi Jal Board pipe line are not visible and neither the basement as alleged by the complainant is in existence. No further action is warranted in the matter. The case is closed at the level of PGC.
