**1. Brief facts of the complaint**

The complainant has filed a complaint against ASI Nathi Lal, Constable Rajinder Kumar and Constable Sanju of police booth Kalkaji Metro Station for illegal detention, threat to eliminate in encounter, getting blank paper signed under pressure and snatching Rs. 26,000/-. The complainant has stated that on 7.9.2017 he alongwith his friends was intercepted for an enquiry by the police personnels at Police Booth Kalkaji Metro Station at 7.00 p.m. Though all their queries were answered and ID of one of his friends was made available to the police, still the police personnel who were drunk misbehaved with them, abused them and even physically thrashed them. On their request to intimate their family members, the police personnel threatened them to eliminate in fake encounter and kept all of them in custody till 11.00 p.m. Apart from this, the police personnel pressurized them to sign some blank papers and also snatched Rs. 26,000/- from them. He has requested for legal action in the matter.

**2. Proceedings in the Public Grievances Commission**

The PGC convened its first hearing in the complaint on 30<sup>th</sup> January, 2018, the second hearing held on 13<sup>th</sup> March, 2018 and the third hearing held on 23<sup>rd</sup> March, 2018, when the following were present:-

### **3 Relevant facts emerging during the hearing**

The alleged police officials of PS Kalkaji are present and reiterated their statements as given in enquiry report of ASI Dayanand, EO/PG Cell/SED, dated 15.11.2017. However, the complainant is again not present to substantiate his allegations. The complainant has not attended any of the three hearings held in the Commission so far. It appears that he is not interested in pursuing his case in PGC.
