### 1. Brief facts of the complaint

The complainant has filed a complaint stating that he is running a "Kirana shop" at E-6/10, Krishan Nagar, Delhi since 38-39 years and he had not paid the rent of the above said shop since 6-7 years as the land-lady of the shop had died 6-7 years ago. He further stated that on 16.4.2017 one Aakash Gupta s/o Suresh Chand (son of landlord of shop) shoot out his son in front of his home H.NO. 9, Gali NO. 1, Shyam Nagar, Delhi. A case vide FIR NO. 111/17, u/s 307/120-B IPC was registered at PS Jagatpuri, Dehi and Police had arrested Aakash Gupta and Mohd. Javed in the case. The complainant also alleged that SI Parveen and SI Rahul Posted in PS Jagatpuri, Delhi have destroyed valuable evidence i.e. CCTV footage and statement of Shilpa from the file. The complainant has requested that as both the IOs have destroyed the valuable evidences in the case, hence, they should be punished u/s 166/166-A/201/217 IPC.

#### 2. Proceedings in the Public Grievances Commission

The PGC convened its first hearing in the complaint on 12<sup>th</sup> February, 2018 and the second hearing held on 19<sup>th</sup> March, 2018, when the following were present:-

## 3 Relevant facts emerging during the hearing

An ATR has been filed by SI Rahul Kumar, PS Jagatpuri, stating that ".....efforts were made to search for any CCTV footage of the alleged offence, but no CCTV footage of the incident was found. At the spot also efforts were done to search any eyewitness of the incident, but none was found. The

complainant has leveled all these baseless allegations just after the Hon'ble Court granted bail to accused persons to mount pressure on accused and also have moved for cancellation of bail to accused. Chargesheet in this case has been filed before the Hon'ble Court on 12.7.2017 the Recovered fire arm and cartridge shells have been sent to FSL for opinion of FSL expert and supplementary chargesheet will be filed in the court after receipt of FSL result and if any other evidence will come on record same will also be filed before the Hon'ble Court alongwith the supplementary chargesheet."

### 4. Directions of PGC

The complainant is present and has requested for expediting the FSL report to bring the case to its logical conclusion.

The case of the complainant is closed in the Commission with the direction to IO present during the hearing to write a letter to FSL for finalizing the report on priority and make efforts to finalize the case by obtaining necessary statements/evidences and file a supplementary chargesheet in the court.
