**1. Brief facts of the complaint**

The complainant has filed a complaint of misbehaviour against police officers of PS Anand Vihar. He has alleged that he alongwith his two sons who visited the police station for registering a complaint against his third son for beating and abusing him was kept in the police station for a long period of eight hours without food inspite of the fact that he is 70 years old. He was roughly treated and taken in hospital on motorcycle for MLC. He has requested for legal action in the matter.

**2. Proceedings in the Public Grievances Commission**

The PGC convened its first hearing in the complaint on 29<sup>th</sup> January, 2018 and the second hearing held on 12<sup>th</sup> March, 2018, when the following were present:-

**3. Relevant facts emerging during the hearing**

Three cases were registered for hearing on similar complaints filed by father son duo. Out of them, one has already been heard and closed in the Commission.

**4. Directions of PGC**

IO is directed to guide the complainant about the concerned Illaka Magistrate for taking cognizance in the NCR/ FIR registered by the police. Further, the complainant is advised to approach the court in the matter of NCR/ FIR. Police is advised to make a detailed report on the incident including
