## 1. Brief facts of the complaint

The complainants has alleged that on 6.5.2009 she got married with Shri Omvir Singh s/o Late Shri Kalyan Singh, r/o Village Sunber Sarai, PO Chhapra, Tehsil Goonaur, PS Dhanari, District Sambal (Uttar Pradesh). After marriage she was harrashed by her in laws family for dowery. The complainant has requested to punish the accused persons for harassing, humiliating, extortion for money and giving threats to kill the complainant, her minor child and other family members and further to provide police protectin to her and her family and further to lodge a FIR against them under appropriate sections of IPC.
