#### 1. Brief facts of the complaint

The complainants have filed a complaint alleging in-action by the police on the complaint regarding beating of their 12 year old son by forcefully entering their house by some 4-5 boys and women. They have also alleged on the same day the alleged people also abused and beaten the complainant. He/his family members made several calls at No. 100 but the police did not reach even after lapse of considerable time. The complainant has requested for necessary action in the matter.
