#### 1. Brief facts of the complaint

The complainant has alleged that Aman, Akbar, Abdulla and others have been living illegally and forcefully in her house. The alleged party uses to call anti-social elements to harass her . She also alleged that on 11.5.2017, net bolt of her rehri were removed and started to break the rehri. When she and her mother objected on their activities, they started to beat her and her mother, as a result her mother got severe injuries. They also beat her sister. A call was made at No 100 but police did not reach on the spot. Again a call was made at No. 100 but police reached very late and police took took them to the police station and kept them to sit in PS for two hours. She further alleged that on 15.4.2017, again the alleged party had beaten them. She made a call at No. 100 but police did not reach on the spot. HC Sudhir reached in her house the next day but did not take any action against the alleged party as the police is favouring the alleged party by taking money from them. The complainant has requested for stern action against the alleged party and registration of FIR in the case.

#### 2. <u>Proceedings in the Public Grievances Commission</u>

The PGC convened its first hearing in the complaint on 31.7.2017, the second hearing held on 9<sup>th</sup> October, 2017, the third hearing held on 5<sup>th</sup> February, 2018 and the fourth hearing held on 19<sup>th</sup> March, 2018, when the following were present:-

### 3 <u>Relevant facts emerging during the hearing</u>

An ATR has been filed by SI Manoj Kumar, PS Seema Puri stating that " a case of property dispute between the complainant and the alleged persons is pending in Court NO. 52, Kardardooma Court. However, on the written complaint of the present complainant, Kalandra u/s 107/150 Cr.P.C. have been prepared and the same are pending with SEM Court Shahdara."

### 4. Directions of PGC

The matter primarily relates to property dispute between the landlord and the occupants of the first floor. It has been informed by the SHO that the matter is pending with the Civil Court as both the parties have made their claim over the property in dispute.

As stated by the SHO, the allegations leveled in the complaint against Aman, Akbar, Abdulla etc. are false and motivated. No credible evidence has emerged during the course of enquiry conducted into the complaint. Taking into account the submission of the police and the fact that the dispute is pending with the Civil Court, the matter is closed in the Commission with the direction to the police that in the event of any such complaint made by the complainant about the safety and security of her mother, police should immediately take prompt action as per law. The complainant is at liberty to approach the police as and when she apprehends any threat to her life.
