1. Brief facts of the Appeal

Shri Vinod Kumar Panwar filed Form-A during December, 2017, with the Competent Authority under Delhi RTI Act, 2001, i.e. Special Director (Administration), Directorate of Education on 2 points.

Shri Vinod Kumar Panwar did receive a response from Special Director (Administration), Directorate of Education. However, being aggrieved with the same, he filed an Appeal during January, 2018, before the Appellate Authority / PGC, under Section 7 of the Delhi Right to Information Act, 2001.
