## 1. **Brief facts of the Appeal**

Shri Anil Dutt Sharma sought information, during June, 2017, from the Competent Authority under Delhi RTI Act, 2001, i.e. Deputy Commissioner (Shahdara North Zone), East DMC, seeking information on total 8 queries.

Shri Anil Dutt Sharma did receive a reply from the Office of Deputy Commissioner (Shahdara North Zone), East DMC, but he was not satisfied with the same. Hence, he filed an Appeal during August, 2017, before the Appellate Authority / PGC, under Section 7 of the Delhi Right to Information Act, 2001.
