1. Brief facts of the Appeal

Shri Manoj Kumar Sharma sought information, during June, 2017, from the Competent Authority under Delhi RTI Act, 2001, i.e. Deputy Commissioner (City SP Zone), North DMC, making queries on total 26 counts.

Shri Manoj Kumar Sharma received no response from the Office of Deputy Commissioner (City SP Zone), North DMC. Hence, he filed an Appeal during August, 2017, before the Appellate Authority / PGC, under Section 7 of the Delhi Right to Information Act, 2001.

2. Proceedings in the Public Grievances Commission

The Public Grievances Commission has convened its first hearing on 22nd February, 2018. At today's hearing on 22/02/2018, the attendance was as follows :

3. Relevant facts emerging during the hearing

- 3.1 At today's hearing on 22/02/2018, representative of the department submitted a reply dated 21/02/2018 before the Appellate Authority. The reply was examined.
- 3.2 On perusal of reply, it has been revealed that the department has provided satisfactory information in respect of Query Nos., b,c,d,e,f,g,i,j,k,l,m,q, s,v and z, hence no further action is required in the matter.
- 3.3 In respect of Query No. (a) & (h), the information asked by the appellant is not a 3rd party information and total area to be provided to the appellant.
- 3.4 In respect of Query No. (n) & (o), dates when notices were issued / orders executed may be provided but not copies of orders.
- 3.5 In respect of Query No. (p) & (r) the information asked by the appellant cannot be treated as 3rd party information and the same should be provided.
- 3.6 In respect of Query No. (t) date and file number vide which Completion Certificate issued may be given.
- 3.7 In respect of Query No. (u), (w), (x) and (y), the information should be provided to the appellant.

4. Directions of the PGC

- 4.1 Since the reply in respect of Query No. (b), (c), (d), (e), (f), (g), (i), (j), (k), (l), (m), (q), (s), (v) and (z) are found satisfactory, no further action is required on these points.
- 4.2 In respect of Query Nos.(a), (h), (n), (o), (p), (r) , (t), (u), (w), (x) and (y), revised reply should be provided to the appellant as directed in para 3.2 to 3.7 above to the appellant within 15 days from the date of issue of this Order, with a copy to the Commission.
- 4.3 The reply should be furnished to the appellant under the signatures of Competent Authority, properly stamped, having the name of the Competent Authority (documents, if any, appended with the reply should be certified either by the Competent Authority or an official deputed by the Competent Authority).

With the above directions / observations the present appeal case is ordered to disposed of before the Appellate Authority / Member (PGC).

Since the appellant was not present, copy of the reply received from the Competent Authority be sent to the appellant alongwith the order.
