3. Relevant facts emerging during the hearing

An ATR has been filed FSO, Circ.02 GNCT of Delhi stating that "The card no. 077004930761 was rejected/cancelled on 26.10.2015 as the income of the applicant Smt. Ram Biri was more than one lac. The ADM/DGRO (North) has sought the comments vide letter dt. 9.1.2018 and the same was sent vide this office letter dt. 25.1.2018. As soon as the approval of the ADM.DGRO (North) for issuance of ration card in r/o Smt. Ram Biri will be received, the same will be processed on priority.

It is pertinent to mention here that the process of issuance/cancellation of existing ration card and of making new ration card has been stopped till further order vide order dt. 10.3.2018."

As per the ATR the complainant's ration card was cancelled in 2015 on the ground that family income was more than one lakh per annum presently.

At present matter is pending with ADM who is Appellate Authority. The deptt. had already given comments to the ADM for taking decision. Since the concerned authorities are already seized with the matter, Commission closes the matter.

In view of above, the Commission has decided to close the case.
