**1. Brief facts of the complaint**

The complainant has filed a complaint of harassing his wife by some boys/girls residing in the same building. It has been further alleged that one of the said boy when requested by his wife to take away the dog she was abused by the boy. The Uttam Nagar police did not take any action despite his complaint in this regard.

**2. Proceedings in the Public Grievances Commission**

The PGC convened its first hearing in the complaint on 21<sup>st</sup> February, 2018 and the second hearing held on 28<sup>th</sup> March, 2018, when the following were present:-

**3 Relevant facts emerging during the hearing**

An ATR has been filed by ASI Ajit Singh, NO. 2634/DW/PS Uttam Nagar stating the following :-

i. On receipt of the complaint I went to the given address and conducted enquiry and as per outcomes of enquiry and contents of the complaint, action u/s 506 /IPC has been taken vide FIR No. 29/2018. A copy of the FIR has been delivered to the complainant.

ii. As per the direction of Hon'ble Commission, I went to the given address and conducted enquiry about the alleged persons. On enquiry it found that alleged girl has vacated the accommodation before one and half month, and went somewhere else. On enquiry about boys it came to notice that they have been shifted to Bangalore for their work."

**4. Directions of PGC**

The complainant is not present. He has not attended any of the two hearings held in the Commission so far. It appears that he is not interested in pursuing his case in PGC. Efforts were made to contact the complainant to know his view regarding the police action taken on his complaint, but he did not pick the phone.

However, as per the ATR, the case has already been registered on his complaint.

IO is directed to conclude the investigation and file a charge sheet expeditiously.

With the above advice, the Commission has decided to close the case in PGC.
