1. Brief facts of the Appeal

Shri Subhash Chand filed Form-A during June, 2017, with the Competent Authority under Delhi RTI Act, 2001, i.e. District Magistrate (North), Revenue Department, making queries on total 01 count.

Shri Subhash Chand did not receive any response from the Office of District Magistrate (North), Revenue Department. Hence, he filed an Appeal during July, 2017, before the Appellate Authority / PGC, under Section 7 of the Delhi Right to Information Act, 2001.

2. Proceedings in the Public Grievances Commission

The PGC has so far convened three hearings on 28th August, 2017, 30th October, 2017 and 22nd January, 2018. At today's hearing 22/01/2018, the attendance was as follows :

3. Relevant facts emerging during the hearing

- 3.1 At today's hearing on 22/01/2018, appellant was not present. Representative of the department submitted that a reply had already been sent to the appellant vide letter dated 08.01.2018 (copy placed in the file).
- 3.2 On perusal of the reply, it has been revealed that the department has provided satisfactory information in respect of the queries raised by the appellant in his DRTI application, hence no further action is required.

4. Directions of the PGC

- 4.1 **Since the department has provided satisfactory reply to the queries of the appellant, no further action needs to be taken in this regard. Accordingly, the present appeal case is ordered to be disposed of before the Appellate Authority / PGC.**
- 4.2 The appeal case is closed in the Commission. However District Magistrate (North) is advised to ensure that the case pending before Revenue Assistant (Alipur) may be concluded expeditiously, preferably within 3 months of issue of this order since the matter is already pending for more than one year before the Revenue Assistant (Alipur).
