1. Brief facts of the complaint

Sh. G.C.Sharma filed a complaint in PGC on 30.1.2018 regarding revision of pension of pre 2006 pensioners.

2. Proceedings in the Public Grievances Commission

The PGC convened first hearing on 4.4.2018 wherein the following were present:

3. Relevant facts emerging during the hearing

An ATR has been filed on behalf of SREO (Admn.) (Employment), GNCT of Delhi stating that *"His case for revision of pension of pre-2006 pensioners along with revise of pension of pre-2016 pensioners was forward to PAO-X, Delhi Secretariat, New Delhi vide this office letter no. F.10(58)/Emp./Admn./2017/330-32 dt. 2.2.2018 PAO X in turn issued revised PPO dt. 13.2.2018 pensioners copy of which has been sent to Sh. G.C. Sharma retired SREO vide this office letter no. F. 10(58)/Emp./Admn./2017/999 dt. 23.3.2018"*.

The ATR indicates that pension has been revised and sent to PAO-X for doing the needful. PAO- X has already issued revised PPO number on dt. 13.2.2018 and it is been communicated to Sh. G.C. Sharma.

The complainant however, stated the issue of extending the benefit of order of Govt., issued on dt. 6.4.2016 and 12.4.2016, regarding giving full pensionary benefit to those who retired before 2006. This needs to be attended to. SREO (Admn.)/Nodal Officer/Director Employment present has collected the copies of the notification of above mentioned order of Govt. of India and has been advised to take necessary action.

4. Directions of the PGC

With the above direction the Commission has decided to close the case.
