### 1. Brief facts of the complaint

Sh. Mahadev Tiwari, filed a complaint in PGC on 16.3.2018 regarding interest on payment of differential pension of Rs. 247204/- in respect to late Mrs. Laxmi Tiwari is not paid from 13.8.2012 till date.

#### 2. <u>Proceedings in the Public Grievances Commission</u>

The PGC convened its hearings on 3.4.2018 wherein the following were present:

#### 3. Relevant facts emerging during the hearing

An ATR has been filed by V.K.Verma, Principal, GB Pant Institute of Technology stating therein that:-

"That all the due payable on the death of Sh. Bharat Tiwari were paid to Smt.Laxmi Tiwari which included Death Gratuity, General Provident Fund, leave

encashment, CGEIS, saving fund and DLI were paid vide bill dated 7.11.2006 to 3.5.2007.

That a pension pay order 692700700432 dt. 23.4.2007 issued vide file no. 147/405-407 dt. 25.4.2007 addressed to the Pay and Account Officer, Central Pension Accounting Office, Ministry of Finance, Govt., of India, Trikoot-II Complex, Bhikaji Cama Place, ND was issued PAO -23,Sriniwaspuri, Delhi for making payment of pension......thtPO-23 vide letter no. 2193 dt. 13.8.2012 addressed to Pay and Accounts Officer revised the family pension of Ms. Laxmi Tiwari W/o Late Sh. Bharat Tiwari Ex-WSI. In this letter vide para-2 revised family pension was conveyed vide para-4 additional amount of DCRG payable by the bank due revision Rs. 306370/- and details of disbursing bank vide para-7 have been conveyed to PAO, Central Pension Accounting Officer. The aforesaid letter w as acknowledged on behalf of Smt. Laxmi Tiwari on the body of Annexxure11 and 12.

That PAO-23 vide letter dt. 21.3.2018 has intimated that on the basis of revised authority CPAO had also issued the revised special seal authority to the bank well in time for arranging the payment of family pension/gratuity. As such there is no delay on the part of this institute or PAO-23."

Since the complainant is not present and has not signed the declaration about court proceeding, the Commission is unable to take it up forward. In the meanwhile College authority has given ATR which has given details of the issue. The representative of the college has stated that there appears to be case pending in the Hon'ble CAT as well in the same matter.

## 4. <u>Directions of the PGC</u>

In view of above, in the absence of complaint and his declaration Commission closes this matter.
