1. Brief facts of the Appeal

Smt. Durgesh sought information, during July, 2017, from the Competent Authority under Delhi RTI Act, 2001, i.e Assistant Commissioner (West), Department of Food, Supplies & Consumer Affairs, making queries on total 8 counts.

Smt. Durgesh did receive a reply from the Office of Assistant Commissioner (West), Department of Food, Supplies & Consumer Affairs, but she was not satisfied with the same. Hence, she filed an Appeal during September, 2017, before the Appellate Authority / PGC, under Section 7 of the Delhi Right to Information Act, 2001.

2. Proceedings in the Public Grievances Commission

The PGC has convened its first hearing on 26th February, 2018. At the hearing on 26/02/2018, the attendance was as follows :

3. Relevant facts emerging during the hearing

- 3.1 At today's hearing on 26.02.2018, representative of the department had submitted a letter dated 06.02.108 informing that the requisite information under DRTI Act has already been furnished to the applicant vide letter dated 11.08.2017 and later on file inspection allowed to the applicant and photocopies of the requisite documents were provided to the applicant on 21.08.2017 (copy of letter placed in the file). Reply furnished by the department was examined.
- 3.2 The reply furnished by the department has been perused and it is found that the department has provided satisfactory information to the queries raised by the appellant in his DRTI application.

4. Directions of the Appellate Authority / PGC

Since the department has provided satisfactory reply to the queries of the appellant, no further action needs to be taken in this regard. Accordingly, the present appeal case is ordered to be disposed of before the Appellate Authority / Member (PGC).
