1. Brief facts of the Appeal

Sh. Deepak filed Form-A during July, 2017, under the Delhi RTI Act, 2001, with the Competent Authority i.e. Secretary, DSSSB, making queries on total 14 counts.

Sh. Deepak did not receive a response from the Office of Secretary, DSSSB, hence he filed an Appeal during August, 2017, before the Appellate Authority / PGC, under Section 7 of the Delhi Right to Information Act, 2001.

3. Relevant facts emerging during the hearing

3.1 At today's hearing on 12/03/2018, no representative on behlaf of the Competent

Authority was present. The appellant informed that he had received a reply from the

department vide letter dated 06/03/2018. A copy of the same is placed in the file.

3.2 The appellant submitted that the reply is not correct as in respect of Query No. 4,5, 7

and 8, the department informed that the information has already uploaded on the

website of the Board which is in public domain. However, no such information is

available on the website of the department.

3.3 On perusal of the information provided by the department, it has been revealed that the

same is not signed by the Competent Authority, as notified in the DRTI Act-2001.

Further, the Competent Authority should clarify the query raised by the appellant that the

information is not uploaded on the website of the deprtment. Competent Authoruty is

directed to provide the complete route to get the desired information from the website.

4. Directions of the Appellate Authority / PGC

4.2. The Competent Authority i.e. Secretary, DSSSB is directed to furnish a revised

reply, as advised in para 3.3 above to the appellant within 10 days from the date of

issue of this order, with a copy to the Commission. The reply should be furnished

to the appellant under the signatures of Competent Authority, properly stamped,

having the name of the Competent Authority (documents, if any, appended with

the reply should be certified either by the Competent Authority or an official

deputed by the Competent Authority).

Accordingly, the appeal case is ordered to be disposed of before the Appellate

Authority / PGC.
