**1. Brief facts of the complaint**

The complainant has filed a complaint against SHO/PS Bhalswa for evicting her out of her house. The complainant has further stated that on 27.1.2018 around 7.00 p.m. some police personnel of PS Bhalswa visited her house and misbehaved with her saying that she was occupying the house of Kalyani and it was the direction/order of SHO to restore the possession of the house to Kalyani. She has further stated that later on she met the SHO and narrated the incident on which the SHO gave her 15 days to vacate the house and leave the area or she would be put behind the bars. She has alleged that the police personnels threatened her and demanded "rangdari". She has requested for legal action in the matter.

**2. Proceedings in the Public Grievances Commission**

The PGC convened its first hearing in the complaint on 22<sup>nd</sup> March, 2018, when the following were present:-

An ATR has been filed by DCP/North West District, stating that " the matter has been got enquired through ACP/PG Cell/NWD, revealed that documents provided by the complainant and alleged have been verified regarding ownership of the said property i.e. A-600, Mukundpur, Delhi, wherein alleged Smt. Kalyani Singhal is found the registered owner of the aforesaid plot in question. No record of documents (GPA) provided by complainant, was found in Registrar Office. However, the complainant
