1. Brief facts of the complaint

The complainant has alleged that some police officials of Division-6 of P.S. Jaitpur abused and beaten him without any reason. After getting the treatment, he lodged a complaint in the office of Commissioner of Police on 9.1.2017, but no action has been taken on his complaint. He also alleged that police officials beaten him to make a pressure on him to accept the crime of theft. He got injuries on his eyes and ears, as a result his vision weakened. His treatment is still going in Safdarjung Hospital. He also alleged that the police officials took him to private office or house or farm of a property dealer and beaten him badly. The complainant has requested for necessary action in the matter.

2. Proceedings in the Public Grievances Commission

The PGC convened its first hearing in the complaint on 27th June, 2017, the second hearing held on 29th August, 2017, the third hearing held on 31st October, 2017, the fourth hearing held on 9th January, 2018 and the fifth hearing held on 27th March, 2018, when the following were present:-

3 Relevant facts emerging during the hearing

Katju Marg) has been sent to DCP/Rohini District, Delhi for issuing explanation notice as per the direction of Hon'ble PGC.

- iii. Advisory memo to the then ACP/Sarita Vihar i.e. Shri Om Prakash cannot be issued as he has retired on superannuation w.e.f. 31.5.2017."

4. Directions of PGC

DCP/South East District is directed to intimate the outcome of the SCN issued to the erring officials to the Commission within a month of receipt of this order. DCP (Rohini District) is directed to convey the action taken against the then SHO/PS Jaitpur (Now SHO/PS K.N. Katju Marg) within one month of receipt of this order.

With the above advice, the Commission has decided to close the case in PGC.
