1. Brief facts of the Appeal

Shri R. L. Makhija filed Form-A during May, 2017, under the Delhi RTI Act, 2001, with the Competent Authority i.e. Engineer-in-Chief, East DMC, seeking information on total 02 counts.

Shri R. L. Makhija did receive a response from the Office of Engineer-in-Chief, East DMC, but he was not satisfied with the same. Hence, he filed an Appeal during June, 2017, before the Appellate Authority / PGC, under Section 7 of the Delhi Right to Information Act, 2001.

3. Relevant facts emerging during the hearing

3.1 At today's hearing on 04.01.2018, representative of the department submitted that a

reply had already been sent to the appellant vide letter dated 03.12.2018. He submitted

a copy of the same before the Appellate Authority (copy placed in the file).

3.2 On perusal of the reply, it has been revealed that the appellant had filed the application

under DRTI Act with the Competent Authority i.e. Engineer-in-Chief, East Delhi

Municipal Corporation and the Hearing Notice from Appellate Authority was also sent to

the office of Engineer-in-Chief, East Delhi Municipal Corporation. However, the reply

was sent by Deputy Commissioner (Shahdara South), who is not the Competent

Authority in this appeal case.

4. <u>Directions of the Appellate Authority / PGC</u>

4.1 The Competent Authority i.e. Engineer-in-Chief, East DMC, is directed to furnish a

comprehensive reply to the queries of the appellant, as per the information available with

his office, to the appellant within 15 days from the date of issue of this order with a copy

to the PGC.

4.2 The reply should be furnished to the appellant under the signatures of Competent

Authority, properly stamped, having the name of the Competent Authority (documents, if

any, appended with the reply should be certified either by the Competent Authority or an

official deputed by the Competent Authority).

disposed of before the Appellate Authority / PGC.
