1. Brief facts of the Appeal

Shri R. L. Makhija filed Form-A during May, 2017, under the Delhi RTI Act, 2001, with the Competent Authority i.e. Director (Personnel), North DMC, seeking information on total 18 counts.

Shri R. L. Makhija received no response from the Office of Director (Personnel), North DMC. Hence, he filed an Appeal during June, 2017, before the Appellate Authority / PGC, under Section 7 of the Delhi Right to Information Act, 2001.

2. <u>Proceedings in the Public Grievances Commission</u>

The PGC has convened its first hearing on 4th January, 2018. At today's hearing on 04/01/2018, the attendance was as follows:

3. Relevant facts emerging during the hearing

3.1 At today's hearing on 04/01/2018, Shri Kumar Anil Jha, ASO O/o Director (Personnel),

North DMC, stated that a reply, dated 01/06/2017, was furnished to the appellant in response to the queries posed by him, under Delhi Right to Information Act, 2001. He

submitted a copy of the same before the Appellate Authority (copy placed in the file).

3.1 The reply submitted by the department has been examined and it is observed that the

department has provided satisfactory replies in respect of all the queries posed by the

appellant except in respect of Query Nos. 1 and 5.

3.2 In respect of Query Nos. 1 the Appellate Authority is of the view that date of birth, details

of qualifications of a government official cannot be termed as 'Personal Information'. It is

therefore directed the same should be provided to the appellant without photocopies of

these documents. In respect of qualification only passing of year and name of

board/university should be provided.

3.3 In respect of Query No. 5, it would be suffice if details of Experience Certificate

submitted by him at the time of joining is given to the appellant. Copies of Experience

Certificate need not be given.

4. <u>Directions of the Appellate Authority / PGC</u>

4.1 Since the department provided sataisfactory information in respect of Query Nos. 2, 3, 4,

and 6 to 18, no further action is required in the matter.

4.2 In respect of Query Nos. 1 and 5, revised reply should be furnished to the appellant, as

advised at para 3.3 and 3.4 above within 15 days from the date of issue of this Order,

with a copy to the Commission.

Accordingly, the appeal case is ordered to be disposed of before the Appellate

Authority / PGC.

As the appellant is not present in the hearing today, a copy of the reply submitted

by the department shall be sent to him along with this order.
