1. <u>Brief facts of the complaint</u>

Ms Sushma Sharma filed a grievance in PGC on 06.04.2017 regarding unauthorized construction on govt. land by the owner of H.No. C6/192-193, C-Block, Sultanpuri, Delhi.

3. Relevant facts emerging during the hearing

3.1 At the last hearing held on 9th Feb. 2018, the directions of PGC were as follows:

Ex. Engineer (B-II) and Ex. Engineer (M-II) are advised to complete the removal / demolition of the encroachment after vacation of the premises as per DMC Act.

DCP / SHO Sultan Puri may personally ensure that necessary force / police protection is provided as and when the demolition is scheduled by the MCD.

- 3.2 Neither any officer is present from MCD nor any status report has been submitted.
- 3.3 The complainant is also not present in the hearing.

- 3.4 The owner of the property, against which the complaint is there, has informed that demolition action has been taken 26.03.2018.
- 3.5 SI Manjeet Singh present and requested the Commission to exempt them from the further hearing and assured that whenever the police force will be requested for demolition the same will be provided.

4. Directions of the PGC

Executive Engineer (M-II), Rohini Zone, North DMC is directed to submit a report within 10 days to the effect that needful action has been taken in the matter and after that the matter stands closed at the level of PGC.
