3. Relevant facts emerging during the hearing

3.1 In the hearing on 12/04/2018, representative of the department had informed that a reply

had already been sent to the appellant vide letter dated 14.08.2017. He submitted a copy of the

same before the Appellate Authority / Member (PGC).

3.2 The reply furnished by the department has been perused and it has been found that the

department has provided satisfactory information to the queries raised by the appellant in his

DRTI application except in respect of Query No. 4.

3.3 In respect of Query No. 4, Competent Authority is directed to clarify why no Bio Metric

attendance record is available. If, Sh. Brij Mohan Sharma, UDC/L1 is marking his attendance in

the attendance register in respect of period mentioned in the DRTI application, copy of the same

(only in respect of Sh. Brij Mohan Sharma) may be provided to the appellant.

4. <u>Directions of the Appellate Authority / PGC</u>

4.1 Competent Authority i.e. Deputy Commissioner (Keshav Puram Zone), North DMC

is directed to furnish a revised reply in respect of Query No. 4, as advised in para 3.3.

above to the appellant within 15 days from the date of issue of this order with a copy to

the Commission. The reply should be furnished to the appellant under the signatures of

Competent Authority, properly stamped, having the name of the Competent Authority

(documents, if any, appended with the reply should be certified either by the Competent

Authority or an official deputed by the Competent Authority).
