#### 1. Brief facts of the complaint

Sh. B.K. Vashista filed a complaint in PGC on 31/1/2018 regarding wrong settlement of LTC (Home Town) for the Block Year 2014-2017 by the Education Department.

## 3. Relevant facts emerging during the hearing

An ATR has been filed on behalf of Dy.Director of Education, District North-East, GNCTD, stating that "a meeting was held under the Chairmanship of Mrs.Archana Vishwadeep, DDE (North-East) along with other members.

The matter was discussed thoroughly. The complainant submitted latest rate list of Air India dated 26.2.2018 which was considered and accepted for the disposal of the case and Head of School was advised to pursue the case accordingly.

The Head of the School, GBSS, Shahdara re-examined the matter as per rule and disposed of the grievances of the complainant with the cooperation of the complainant.

The HOS has also submitted an ATR indicating therein that the adjustment bill has been submitted to the concerned PAO-VIII vide billNo.17 dated 12.4.2018, Token No.891 dated 13.4.2018. Accordingly, the adjustment bill passed by the PAO and no recovery / payment is due against the complainant.

Hence, the grievances of the complainant has been sorted out."

The complainant has also stated that his grievances regarding wrong settlement of LTC (Home Town) for the Block Year 2014-2017 has been settled.

In view of the ATR and submissions made by the Departmental Representative and the complainant, the case of the complainant is closed in PGC.
