#### 1. Brief facts of the complaint

The complainant has filed a complaint of inaction against SHO/Burari on her FIR dated 9.5.2017. She has further stated that police has not any action to recover her gold articles from her husband/family. She has also alleged that younger brother of her husband has sexually harassed her but no action was taken by the police. She has requested for legal action in the matter.

#### 2. <u>Proceedings in the Public Grievances Commission</u>

The PGC convened its first hearing in the complaint on  $21^{st}$  September, 2017, the second hearing held on  $7^{th}$  December, 2017, the third hearing held on  $15^{th}$  February, 2018, the fourth hearing held on  $22^{nd}$  February, 2018 and the fifth hearing held on  $12^{th}$  April, 2018, when the following were present:-

#### 3 <u>Relevant facts emerging during the hearing</u>

An ATR has been filed by ASI Sunil Kumar, CAW Cell/North, stating that " the case vide FIR No. 211/17 dated 9.5.2017 u/s 498-A/406/34 IPC, PS Burari was registered on the complaint of Ms. Neha Sharma. During investigation, the alleged person, husband of the complainant had already been arrested and remanded one day PC in the above mentioned case. The dowry articles had already been recovered and the same were deposited in Malkhana, PS Burari. The bills provided by t he complainant were also verified. During the course of investigation, the complainant approached to the Hon'ble High Court for the investigation of 313 IPC as she alleged that she was aborted by her husband in Patel Hospital without her consent on dated

12.6.2014, after that the investigation was transferred to CAW Cell/North the investigation was carried out and during the investigation, the record of the Patel Hospital where the alleged abortion was said to be carried out was obtained and put on file, no record was found in Patel Hospital. The alleged Rahul Sharma was also interrogated twice. All the facts and information has been verified from the Sai Hospital where the complainant approached after the said abortion. The investigation of the case almost done. The chargesheet in the above mentioned case wil be filed shortly. The IO SI Monika of the above mentioned case is on CL upto 16.4.2018 as her father is admitted in the hospital."

#### 4. Directions of PGC

On the last date of hearing, the Commission directed the complainant to be personally present in today's hearing, failing which the PGC will be constrained to close her case. She is neither present nor has sent any communication regarding her absence. It appears that she is not interested in pursuing her case in PGC.

However, the IO is directed to conclude the investigation and prepare draft chargesheet by 20.4.2018.
