**1. Brief facts of the complaint**

The complainant has filed a complaint of inaction against beat officer, Moti Nagar Police Station on his complaint of playing loud speakers at high pitch till 23.30 hours in his neighbourhood. He has also stated that he is a senior citizen, aged 67 years and the beat officer is not paying any visits to him. He has further alleged that the attitude of the said beat officer is careless and indifferent. He has requested for legal action in the matter.

**2. Proceedings in the Public Grievances Commission**

The PGC convened its first hearing in the complaint on 7<sup>th</sup> March, 2018 and the second hearing held on 18<sup>th</sup> April, 2018, when the following were present:-

**3 Relevant facts emerging during the hearing**

**An ATR has been filed by ACP/DIU/West District, stating the following :-**

- i. An enquiry was conducted by Shri Raman Lamba, ACP/Punjabi Bagh, on the basis of enquiry of complaint, above mentioned case (Case FIR No. 104/18, dated 4.4.2018 u/s 3(1)(x) PS Moti Nagar) was registered at PS Moti Nagar and investigation was marked to undersigned.
- ii. During the course of investigation complainant Shri Prem Lal Verma was examined u/s 161 Cr.P.C. and copy of caste certificate issued by D.M. Jaunpur, UP was seized and the same has been sent to the office of D.M. Jaunpur for verification vide No. 393/R-ACP/DIU/West dated 18.4.2018. Investigation of the case is in investigation and being completed according to law."
