1. Brief facts of the complaint

The grievance of the complainant is against IO Shikha, PS Mandawali for delaying the legal action on her complainant.

3 Relevant facts emerging during the hearing

An ATR has been filed by Addl. DCP/East District, stating that “ an enquiry into the matter was conducted through ACP/Mayur Vihar which revealed that a case FIR No. 296/16 u/s 498-A/406/34 IPC has been registered at PS Mandawali. The investigation has been completed from all the possible angles and the chargesheet has been filed against all the 9 accused persons in the Hon’ble Court of Ms. Swati Paliwal, Ld. M.M., Karkardooma Courts,Delhi. The case is pending trial and the next date of hearing is fixed for 13.7.2018.”
