1. **Brief facts of the complaint**

The complainant has filed a complaint against police officials of PS Sunlight Colony for not taking action on her complaint and misbehaviour by ASI Dinesh. She further alleged that her husband married her by fraud as he was already married. She also alleged that her husband made "nude video" of her and is threatening to upload them on "You Tube". She lodged a complaint to PS Sunlight Colony but no action was taken. The complainant has requested for appropriate action against the police officials and get her case registered.

2. Proceedings in the Public Grievances Commission

The PGC convened its first hearing in the complaint on 20th March, 2018 and the second hearing held on 17th April, 2018, when the following were present:-

3 Relevant facts emerging during the hearing

An ATR has been filed by Inspector Fateh Singh, PS Sunlight Colony, stating the following:-

i. On the direction of Hon'ble PGC, matter was enquired from both places mentioned in the complaint. ASI Dinesh No. 196/SE was deputed to verify the facts from Hotels. He went to Hotel, the Park" Connaught Place, Delhi, where Col. M.S. Mangat (Retd.), Director Security & Admnistration gave in writing that Room NO. 716 & 718 were booked in the name of Manish Singhal from 30.12.2017 to 1.1.2018 and IDs of Manish Singhal (Driving License Madhya Pradesh and Voter Card No. HXC1417731) were deposited on the receiption. - complaint was reported /received at hotel reception or security department by t he mentioned room or the side rooms with regard to any noise or quarrel. (Report attached).
- ii. The "Orchha Resort", Tikamgarh, MP was also visited by ASI Dinesh and met with Hemender Singh Chauhan, Manager and enquired into the matter. He gave in writing that Room No. 222 was booked in the name of Mr. Manish Singhal from 21.12.2017 to 22.12.2017. No complaints, no noise was reported/received at hotel reception. (Report Attached).
- iii. Thereafter, ASI Dinesh Kumar visited at Hotel "Kuno Palace", Shyopur, MP, where statement of proprietor Mr. Manohar Meena s/o Shri Mauji Ram Meena, r/o Hotel Kuno Palace, Shyopur (MP) was recorded, therein he stated that Room No. 106 was booked in the name of Manish Singhal and Priya Aggarwal on 22.12.2017 and both were lived peacefully and no quarrel of beatings was reported. They checked out the hotel on 24.12.2017 at 10.00 a.m. (Report Attached).
- iv. However, all the three places menticomplaint are not in the jurisdiction of PS Sunlight Colony, New Delhi. "

4. Directions of PGC

As per the ATR, all the three places mentioned in the complaint are not in the jurisdiction of PS Sunlight Colony, New Delhi.

Inspector Fateh Singh is directed to forward the complaints filed by the complainant in the Police Station Parliament Street for taking further necessary action in the matter.

With the above advice, the Commission has decided to close the case in PGC.
