1. Brief facts of the complaint

Shri A.K.Chaudhary filed a complaint in PGC on 03/02/2017, regarding encroachment on Gram Sabha land at Sector-26 K A-B Pocket, Rohini, behind St. Xavier School, by land mafias in connivance with BDO (North) and other officials.

2. <u>Proceedings in the Public Grievances Commission</u>

The PGC has so far convened 5 hearings in the matter and in the last hearing held on 19th April, 2018 following are present:

3. Relevant facts emerging during the hearing

3.1 At the last hearing held on 21/12/2017, the directions of PGC were as follows:

Since the matter has been stayed by the Hon'ble High Court of Delhi, the PGC cannot issue any directions in the matter at present, till the decision of the Hon'ble High Court of Delhi. Accordingly, the hearing in the present grievance case is adjourned for next hearing.

3.2 During the hearing on 19.04.2018 Sh. Sunil Kumar is present from BDO (North) office and submitted a report from Sh. Kailash Kumar Singh, BDO (North) stating that "it is to inform you that the matter vide WPCNo. 10782/20167 and C.M. No. 42195/2016 and 42197/2016, in the matter of Raj Kumar & Ors. Was fixed on 19.03.2018 aznd now is fixed for hearing before the Hon'ble High Court of Delhi on 23.11.2018 and the interim order(s) is continue (copy of order dated 119.03.2018 is enclosed)."

Hence, no action required to be taken by this office, as the matter is under subjudice.

4. <u>Directions of the PGC</u>

As per report of the BDO (North) the matter is still pending in the High Court and fixed for hearing on 23.11.2018. No action is warranted at the level of PGC at this stage. Hence the case is referred to the Divisional Commissioner for taking a decision in the matter and the case stands closed at the level of PGC.
