1. Brief facts of the complaint

The complainant has filed a complaint stating that SHO/Karawal Nagar alongwith SI Raghunath and two women constables, two police constables forcefully entered his house and assaulted them, abused and threatened to implicate in false cases. He has also alleged that the alleged police personnel demanded money from him. He has also alleged that the police personnel forcefully left Kunti in his house with the threat that if she was evacuated from the house, the complainant , his son, daughter-inlaw would be implicated and arrested in false cases. The complainant has further alleged that he called the police at NO. 100 on which the police turned up on the site and listered to him but no action was taken. The complainant also stated that his mother also got fractured in her right leg for which the doctor advised for immediate operation and rod was put in her leg, she is admitted in the hospital for the same. The complainant has requested for stern action against the alleged persons.

2. <u>Proceedings in the Public Grievances Commission</u>

The PGC convened its first hearing in the complaint on 19th October,2016, the second hearing on 20th February, 2017, the third hearing held on 24th April, 2017, the fourth hearing held on 3rd July, 2017, the fifth hearing held on 4th September, 2017, the sixth hearing held on 13th November, 2017, the seventh hearing held on 15th January, 2018, the eighth hearing held on 26th February, 2018, the ninth hearing held on 26th March, 2018 and the tenth hearing held on 23rd April, 2018, when the following were present:-

3 <u>Relevant facts emerging during the hearing</u>

An ATR has been filed by SI Amit Kumar, stating that on 11.8.2016, an information regarding quarrel was received vide DD NO. 83B & 86 B at PS Karawal Nagar, Delhi which was between the complainant Urmila wife of late Shri Shankar Lal, r/o G-76, Street No. 7, Phase-III,Shiv Vihar, Karawal Nagar and her younger son's wife Kunti. In this quarrelling, complainant Urmila was injured and was taken by PCR van to JPC Hospital Shastri Park and MLC No. 585/16 of the complainant, Urmila was received by IO and on MLC nature of injury was under observation and IO recorded the statement of complainant, Urmila at JPC Hospital, Shastri Park, Delhi MLC was deposited for final opinion and Doctor did not give the final opinion to unsatisfactory film of X-ray and asked to go for X-ray again. As the treatment of the complainant was done at LNJP Hospital, the MLC was again deposited for re-opinion at LNJP Hospital and in opinion nature of injury was given grievous by doctor. On the basis of MLC result case FIR No. 35/18, u/s 325/34 IPC was registered at PS Karawal Nagar on 18.1.2018. In this above mentioned case FIR two accused have been arrested and four others are evading their arrest. The search of other accused is going on and investigation in progress, chargesheet will be prepared shortly after interrogation/arrest of other left over accused."

4. Directions of PGC

IO is directed to conclude the investigation expeditiously and file a chargesheet in the Court at the earliest.

With the above advice, the Commission has decided to close the case in PGC.
