1. Brief facts of the complaint

The complainant has alleged that he had purchased a 100 square yards plot from a property dealer Shri Surinder Kumar Prajapati for Rs. 12 lakhs in the year 2012. The plot remained unconstructed due to lack of money but he frequently visited the same. In 2016 after the death of Shri Surinder Kumar Prajapati, when he went to his plot he was shocked to see that one so called property dealer Shri Satish Chauhan was trying to build a boundary wall on his plot for which he immediately made a complaint to the police. The police turned up but instead of listening to his complaint he was misbehaved. He has further alleged that the alleged property dealer called him in his office on 20.9.2016 for a compromise in the matter. Shri Kuldeep Singh, SI /IO also came there and pressurized the complaint to write a compromise letter dictated by him. He has also alleged that the said IO was also hands in glove with the alleged property dealer in the conspiracy of illegal possession of his plot. He has requested for legal action in the matter.

2. <u>Proceedings in the Public Grievances Commission</u>

The PGC convened its first hearing in the complaint on 16th February, 2017, the second hearing on 13th April, 2017, the third hearing held on 20th July, 2017, the fourth hearing held on 21st September, 2017, the fifth hering held on 15th February, 2018, the sixth hearing held on 15th March, 2018 and the seventh hearing held on 26th April, 2018, when the following were present:-

An ATR has been filed by SHO/PS Swaroop Nagar, stating the following :-

i. During enquiry statement of the complainant Didar Singh was recorded who submitted that he stands with his complaint given on 30.9.2016 and nothing to add in it and during his interview he could not produce any independent witness or any credible evidence in support of his allegation against SI Kuldeep. During enquiry it was found that on the day of

allegation SI Kuldeep was gone to attend a matter in Delhi High Court and when he attend to Police Station, Didar Singh met him and asked for a blank paper accordingly. He gave a blank paper to him. Thereafter, he wrote his complaint and submitted t he same to DO/PS Swaroop Nagar vide DD NO. 72-B dated 20.9.2016. His version was supported by SI Jagdeep Singh No. D-4257 of PS Swaroop Nagar, who was present there at that time. During examination Satish Chauhan was also examined who stated that he has nothing to do with the said plot as the same has been purchased by his partner Aakash Kashyap and he submitted chain of plot in question. He further stated that on humanitarian ground be advised Didar Singh to go the son of Surender Parjapti to settle his grievance . He never called Didar Singh in his office rather then he came to his office at his own wishes. During enquiry Jitender Kumar son of Surender Parjapati was also examined, who stated that he is a student and after the death of his father he runs a shop as his livelihood. His father was doing property business and during his life he visited sometime to Dedar Singh and he also bring money from him and gave to his father but he did not know about this transaction and neither aware about any plot.

ii. During enquiry the documents submitted by Satish Chauhan the alleged person of plot NO. 32, area measuring 200 sq.yards, out of Khasra NO. 144 and 145, Village Bhalswa, Jahangirpuri now known as Vijay Chowk, Swaroop Nagar, Delhi was also checked which are as under :-

However, the complainant produces only the photocopies of GPA, Agreement to sell, will and payment receipt but could not provide its complete chain. During enquiry it came into notice that on 17/12/2014, Surender Parjapati committed suicide and proceeding u/s 174 Cr.P.C. was conducted. Deceased sold many property/plots to various persons on forged papers without any right. On pressure, he committed suicide. After his death, many persons are coming forward everyday to claim plots om the area of PS Swaroop Nagar which were purchased thorugh deceased Surender Parjapati. Thus, Surender Parjapati was not found genuine owner of such plots which he sold to complaints. However, present complainant is genuine purchaser and cheated by Surender Parjapati by giving forged and fabricated documents.

- iii. During enquiry complainant could not produce any credible witness and evidence regarding allegations leveled against SI Kuldeep Singh. Hence, in the absence of any proof/credible evidence allegations leveled by t he complainant could not be substantiated. However, about the documents of the complainant it is submitted that the same has already been verified in the year-2015 and found fake. No further enquiry into the matter is pending with police presently.
- iv. Further, as per report submitted by the BDO/Alipur in Hon'ble Commission, the land in question has been vested in Gram Sabha on 9.5.2007. The possession of the land is yet to be handed over to BDO/North and presently the matter is pending with SDM/Alipur.

4. Directions of PGC

As per the ATR filed by SHO/PS Swarup Nagar and BDO North, the land in question has been vested in Gram Sabha vide order dated 9.5.2001 and the matter is pending in the court of RA/SDM (MT).

The complainant is advised to take legal re-course for redressal of his grievance.

With the above advice, the Commission has decided to close the case in PGC.
